

Official Rules for the BoxLunch High Speed to Universal Studios Hollywood Sweepstakes
("Sweepstakes")

No Purchase Necessary to Enter or Win. A Purchase Will Not Increase Your Chances of Winning.

ALL ENTRANTS AGREE TO RESOLVE ANY DISPUTE BY BINDING ARBITRATION AND SHALL BE IN THE ENTRANT'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING. THE ARBITRATOR MAY NOT CONSOLIDATE OR JOIN THE CLAIMS OF OTHER PERSONS OR PARTIES WHO MAY BE SIMILARLY SITUATED. DO NOT ENTER THIS SWEEPSTAKES IF YOU DO NOT AGREE TO HAVE ANY CLAIM OR CONTROVERSY ARBITRATED IN ACCORDANCE WITH THESE OFFICIAL RULES.

1. **Eligibility.** The Sweepstakes is open only to legal residents of the fifty (50) United States (excluding Rhode Island) who reach the age of majority¹ in their state by the Sweepstakes start date. Employees of Hot Topic, Inc. dba BoxLunch ("Sponsor"), Universal City Studios LLC d/b/a Universal Studios Hollywood ("Universal", "Universal Studios Hollywood", or "USH"), and each of their respective parent and subsidiaries, as well as the immediate family (spouse, parents, siblings, and children) and household members of those employees, are not eligible to enter.
2. **Entry Period.** The Sweepstakes begins at 9:00 AM Pacific Time on July 27, 2026, and ends at 11:59 PM Pacific Time on August 16, 2026 (the "Entry Period"). Entries submitted before or after the Entry Period will not be eligible. Sponsor's computer is the official time-keeping device for the Sweepstakes.
3. **How to Enter.** During the Entry Period, an eligible entrant may submit up to two (2) total entries by participating through two methods:
 - I. Website Entry Form: For the first method of entry, during the Entry Period, for one (1) entry, you must:

 - (ii) confirm you meet eligibility requirements as outlined in Section 1 above, and
 - (iii) consent to these Official Rules and BoxLunch's [Privacy Policy](#) and [Terms of Use](#).
 - (iv) You may optionally opt in to receive marketing communications; this is not required to enter the Sweepstakes.²

¹ The age of majority is 18 for all states except for: Alabama (19), Arkansas (18 or graduation from high school, whichever is later), Delaware (19), Mississippi (21), Nebraska (19), Nevada (18, or if still in high school at 18, 19 or graduation, whichever comes sooner), Ohio (18 or graduation from high school, whichever comes first), Tennessee (18 or graduation from high school, whichever is later), Utah (18 or graduation from high school, whichever is earlier), Wisconsin (18, or if still in high school at 18, 19 or graduation, whichever comes sooner).

² Signing up for BoxLunch marketing and promotional emails is not a requirement to enter the Sweepstakes.

II. Instagram Post Entry: As an alternate method of entry, during the Entry Period, for one (1) entry, you must:

- (A) Be following the @BoxLunchGifts Instagram account,
- (B) Press “like” on the Instagram image/video posted on July 27, 2026 around 9:00 AM Pacific Time to the @BoxLunchGifts Instagram account (the “Post”), and
- (C) Tag one (1) other Instagram account with the keyword “Fast” in the comments section of the Post.

There is a limit of two (2) entries per person, consisting of one (1) entry via the Website Entry Form and one (1) entry via the Instagram Post. All entries must be complete and subject to verification by the Sponsor, in its sole discretion. Entries with inappropriate comments or images may be disqualified at the sole discretion of Sponsor.

You may not use an agency or any automated system to enter, and Sponsor reserves the right to disqualify any entries received through those methods, as determined by Sponsor, in its sole discretion.

By entering, you indicate your full agreement to these Official Rules and Sponsor’s decisions regarding the Sweepstakes, which are final and binding. Winning the prize is contingent upon fulfilling all requirements in these Official Rules.

- 4. **Winner Selection.** On or about August 17, 2026, Sponsor will select one (1) grand prize winner in a random drawing of all eligible entries received. The odds of being selected depend on the number of eligible entries received during the Entry Period. Sponsor will attempt to notify the potential winner within three (3) business days of the drawing via Instagram Direct Message at the Instagram account used to enter. Up to three (3) attempts will be made to contact the selected winner following the draw. A selected winner that does not or cannot accept a prize may be forfeited and a new winner will be selected by random drawing of all remaining eligible entries received during the Entry Period, in Sponsor’s sole discretion.
- 5. **Winner Requirements.** Except where prohibited, a selected winner will be required to complete and return a declaration of eligibility and liability/publicity release. If a winner fails to sign and return these documents within the required time period, and time permits, an alternate winner may be selected in a random drawing of all remaining eligible entries received during the Entry Period. Only one (1) alternate winner may be contacted. Sponsor is not responsible for any failure by a selected winner to receive the prize notification or for any failure of Sponsor to receive a selected winner’s response, regardless of cause.
- 6. **Prizes.** The following prizes will be awarded:

One (1) grand prize winner will receive the following as a part of the Grand Prize Package (“Grand Prize Package”):

- A. A Three (3) day, two (2) night trip for Winner and up to three (3) Guests (“Guests”) to Universal Studios Hollywood in Universal City, California (the “USH Prize”). The USH Prize will include:
 - i. Round-trip economy class air transportation from a major commercial airport near the Winner’s home (as determined by Universal Studios Hollywood, in its sole discretion) for Winner and up to three (3) Guests to Los Angeles, CA* (the Winner will be responsible for ground transportation to/from the airport at point of origin);

- ii. Two (2) nights' standard hotel accommodation (one (1) room, quadruple occupancy, room and tax only) at Sheraton Universal Hotel (or at another nearby hotel, as determined by Universal Studios Hollywood in its sole discretion);
- iii. Non-exclusive ground transportation to and from airport and hotel in Los Angeles, CA*; and
- iv. 2-Day General Admission tickets to Universal Studios Hollywood theme park each for the Winner and up to three (3) Guests.

*For a winner who is a California resident, air transportation may be substituted with another method of transportation by Universal Studios Hollywood, in its sole discretion.

The Approximate Retail Value ("ARV") of the USH Prize is Four Thousand Four Hundred Fifty Dollars (\$4,450 USD) (actual value may vary depending on departure date and location).

The FMV of the *Fast & Furious* Night Fury Suki Moto Racing Jacket, *Fast & Furious* Toreto Mechanic Shirt, *Fast & Furious* Garage Jacket, *Fast & Furious* Racing Jacket, *Fast & Furious* World Tour FHBH Tee, and *Fast & Furious* Family FHBH Tee is Four Hundred Seventy-Four and 40/100 Dollars (\$474.40 USD) (actual value may vary).

The total FMV of the Grand Prize Package is Four Thousand Nine Hundred Twenty-Four and 40/100 Dollars (\$4,924.40) (actual value may vary).

Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication.

In the event of a dispute as to the owner of an entry, the authorized account holder of the Instagram account or the email address used to enter will be deemed to be the owner.

The Sweepstakes is subject to federal, state, and local laws and regulations and is void where prohibited. These Official Rules will prevail and control over all shortened versions of these Official Rules found elsewhere. Sponsor shall have the right to interpret and apply these Official Rules to individual circumstances in its reasonable discretion.

Sponsor reserves the right to terminate or amend this Sweepstakes at any time and in any way, without prior notice to entrants. Sponsor reserves the right, in its sole discretion, to amend or modify these Official Rules, or modify, cancel, or suspend this Sweepstakes, without prior notice for any reason whatsoever, including without limitation in the event that any cause beyond the reasonable control of the Sponsor corrupts, or threatens to corrupt, the security or proper administration of the Sweepstakes.

9. **Privacy and Publicity.** Any information you submit as part of the Sweepstakes will be used in accordance with Sponsor's [Privacy Policy](#). 11. **Governing Law, Arbitration, and Class Action Waiver.** THESE OFFICIAL RULES AND THE INTERPRETATION OF THESE OFFICIAL RULES WILL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF CALIFORNIA, WITHOUT REGARD TO ITS CONFLICTS OF LAWS PRINCIPLES.

("JAMS"), PURSUANT TO THE JAMS STREAMLINED ARBITRATION RULES & PROCEDURES EFFECTIVE JUNE 1, 2021 (THE "JAMS RULES"), AND AS MODIFIED BY THIS AGREEMENT TO ARBITRATE; (2) CONDUCTED BY A SINGLE, NEUTRAL ARBITRATOR; AND (3) TAKE PLACE TELEPHONICALLY UNLESS AN IN-PERSON HEARING IS SPECIFICALLY REQUESTED BY EITHER PARTY, IN SUCH CASE IN-PERSON HEARINGS SHALL TAKE PLACE AT A MUTUALLY AGREED UPON LOCATION, OR IF THE PARTIES CANNOT MUTUALLY AGREE UPON A LOCATION, THE COUNTY WHERE YOU RESIDE. TO THE EXTENT THAT THIS AGREEMENT TO ARBITRATE CONFLICTS WITH THE JAMS POLICY ON CONSUMER ARBITRATIONS PURSUANT TO PRE-DISPUTE CLAUSES MINIMUM STANDARDS OF PROCEDURAL FAIRNESS (THE "MINIMUM STANDARDS"), THE MINIMUM STANDARD IN THAT REGARD WILL APPLY.

DISPUTES MAY ALSO BE REFERRED TO ANOTHER ARBITRATION ORGANIZATION IF YOU AND SPONSOR AGREE IN WRITING, OR TO AN ARBITRATOR APPOINTED PURSUANT TO SECTION 5 OF THE FEDERAL ARBITRATION ACT.

To commence an arbitration, a Demand for Arbitration is required to be executed and served on Sponsor. Service of the Demand for Arbitration on Sponsor can be mailed to Hot Topic, Inc., ATTN: Hot Topic Legal Department, 18305 E. San Jose Ave., City of Industry, CA 91748, pursuant to the instructions provided by JAMS to submit a Dispute for arbitration.

BECAUSE THE SWEEPSTAKES PROVIDED TO YOU BY SPONSOR CONCERNS INTERSTATE COMMERCE, THE FEDERAL ARBITRATION ACT ("FAA") GOVERNS THE ARBITRABILITY OF ALL DISPUTES. HOWEVER, APPLICABLE CALIFORNIA STATE OR U.S. FEDERAL LAW MAY ALSO APPLY TO THE SUBSTANCE OF ANY DISPUTES. YOU AND SPONSOR VOLUNTARILY AND KNOWINGLY WAIVE ANY RIGHT YOU OR SPONSOR HAVE TO A JURY TRIAL.

NO CLASS ACTIONS. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, YOU AND SPONSOR AGREE THAT ANY AND ALL DISPUTES WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS OR COLLECTIVE ACTION. NEITHER YOU NOR SPONSOR SHALL BE ENTITLED TO JOIN OR CONSOLIDATE CLAIMS IN ARBITRATION BY OR AGAINST OTHER ENTRANTS/CONSUMERS, OR ARBITRATE ANY DISPUTE AS A

REPRESENTATIVE OR MEMBER OF A CLASS. Further, unless both you and Sponsor expressly agree otherwise, the arbitrator may not consolidate more than one person's claim. If this prohibition of class, representative, or consolidated arbitration is found to be unenforceable, then the entirety of this arbitration provision shall be null and void.

In the event you commence arbitration, after Sponsor receives notice that you have initiated arbitration, Sponsor will promptly reimburse you for your payment of the filing fee and Sponsor will pay any case management fees associated with the arbitration and the professional fees for the arbitrator's services.

This Sweepstakes is not sponsored, endorsed, or administered by, or associated with Facebook, Instagram, or X. By entering the Sweepstakes, you agree to release Facebook, Instagram, and X from any and all claims.

14. **Prize Provider & Arbitration.** Universal City Studios LLC d/b/a Universal Studios Hollywood is the prize provider only in this promotion; is not the sponsor of this promotion; and is not responsible for the administration of the promotion, the collection of the entries or the selection of any winner. Any disputes, claims and causes of action against Universal Studios Hollywood arising out of or relating to any person's use of, or participation in the USH Prize involving Universal Studios Hollywood shall be fully and finally adjudicated by binding arbitration to the fullest extent allowed by law (an "Arbitration") in Los Angeles, California. The Arbitration shall be administered by JAMS in accordance with the Streamlined Arbitration Rules and Procedure of JAMS (available at <https://www.jamsadr.com/rules-streamlined-arbitration/>) or subsequent versions thereof, including the optional appeal procedure.
